Your Contributions to Moving forward the JPP ERA-Net SES Initiative

The JPP ERA-Net SES initiative lives from the funded projects and their work bringing in valuable results, activities and achievements. To maximize impact and create cross-border and cross-project learning effects, exchange, collaboration and cooperation among projects are indispensable when finding solutions for cross-cutting challenges. Hence, it is one of our initiative's key features that all funded projects and their representatives are active members of the JPP ERA-Net SES Knowledge Community and its Working Groups. The JPP ERA-Net SES Support Team manages the Knowledge Community and Working Groups and thereby facilitates your active participation in these activities. Please note that all projects are required to be represented in the Working Groups, report to the initiative and run communication activities. Related costs are covered by the budget planned in your Knowledge Community Standard Work Package.

Your Project's Reporting: Annual and Final Reporting in 2022

To make most of the results and receive feedback, JPP ERA-Net SES projects are required to regularly report to the initiative. **The reporting tool will be active from 17 January 2022 for all projects.** The projects submitting an annual report have to do so by 15 March 2022.

Please note that for the projects ending in 2022, the following schedule applies:

- projects, which end **by 30 June 2022**, have to submit a final report. The reporting deadline for each project will be the project's official end date in 2022.
- projects, which end **after 30 June 2022**, have to submit an annual report by 15 March 2022 and a final report by the project's official end date in 2022. For the final report you may build upon the information submitted for the annual report.

All listed project managers and owners have received an e-mail with first information on the reporting and will receive an e-mail with final information on the reporting in January.

Please note the prerequisites for accessing the reporting tool:

- be a registered expera expert (register here)
- be **listed as project manager/owner** or assigned by those as reporter for the project (changes to be communicated to knowledgecommunity@eranet-smartenergysystems.eu)

Your Project's Participation and Representation in the Working Groups

Opportunities for expanding your knowledge, developing your network and disseminating your findings – this is what the JPP ERA-Net SES initiative offers to all funded projects. The Family of Projects – together with further experts in the field of smart energy systems – forms the JPP ERA-Net SES Knowledge Community with its extensive and exclusive international knowledge base. **The thematic Working Groups are at the core of the Knowledge Community.** They provide a powerful discussion forum and feed the Knowledge Community with state-of-the-art findings. The Working Groups are composed of two types of participants: core participants are experts from the funded projects interested in the specific topics and additional participants are experts of other interested parties willing to contribute to the specific topics.



The output of the Knowledge Community, in particular the **yearly editions of Policy Briefs and Spotlights**, helps programme managers and policy makers from the involved funding partners to shape future funding programmes. **Hence, your participation and representation in the Working Groups makes your voices heard at the European policy level!**

Working Group Meetings in 2022

The thematic Working Groups meet regularly to discuss developments and exchange experiences. Contingent upon arising tasks and topics, about three meetings take place each year per Working Group. The Working Groups launched the co-creation cycle for 2022 at the Working Group Meetings in November 2021 and are already in the middle of their work to contribute to discission documents from which the 2022 edition of Policy Briefs and Spotlights will be developed. For 2022, Working Group Meetings are planned for Winter (January/February 2022), Spring (March 2022) and Autumn (October/November 2022).

Background on the Development of Policy Briefs and Spotlights by the Working Groups

Starting with the JPP SES Conference 2020, we introduced an advanced element for cooperation and co-creation within the international SES innovation world. The Working Groups will regularly relate the findings from JPP ERA-Net SES funded projects to the research outside our own ecosystem. To that end, Working Group members, first, **select a set of relevant reference documents**, i.e., directives, meta-studies, reports and roadmaps and, second, **contribute to living discussion documents** to compare the outcomes of their projects with the positions described in the reference documents. From this, Policy Briefs and Spotlights are then developed to reveal the impact and relate the knowledge of JPP ERA-Net SES funded projects to the rest of the world. **Watch our introductory video** to this approach and find more information below on the 2021 Edition of Policy Briefs and Spotlights.

Please note that the dissemination template is to be uploaded as attachment on the expera reporting site and on your expera project database profile with the final report submission.

The process of selecting projects for funding within the Joint Programming Platform's and Mission Innovation's Joint Call 2020 ("MiCall20") on Digital Transformation for Green Energy Transition is now completed. The Joint Call 2020 completes the successful start of the JPP ERA-Net SES Focus Initiative on Digitalisation of the Energy System ("EnerDigit").

JPP Smart Energy Systems Conference 2021 Documentation Available

A big thank you to all who joined our JPP Smart Energy Systems Conference 2021, 23-25 November, and made the virtual conference such a successful event – paving the ground for the future of smart energy systems! The conference started with the **Policy Conference** on 23 November, where different stakeholders from the energy sector joined to discuss upcoming, present and past activities of the JPP ERA-Net SES initiative as well as our partner programmes, such as the Project Chains Programme. During the **Status Conference** on 24 November, four



concluding JPP ERA-Net SES projects pitched their final results to the audience and received valuable feedback from selected JPP ERA-Net SES partners and 15 JPP ERA-Net SES projects organised their own successful sessions to facilitate discussions on their latest results. In the afternoon, the JPP ERA-Net SES projects kicked-off the new co-creation cycle within the Working Group Meetings. The conference ended with the **Family of Projects Meeting** on 25 November, where the JPP ERA-Net SES projects created future ideas for the Knowledge Community and jointly learned about effective means of communication.


2021 Spotlights are Published and 2021 Policy Briefs are Featured in a Podcast
