ERA-Net SES Virtual Working Group Meetings, November-December, 2018

The annual series of [Virtual Working Group \(WG\) Meetings](#) has taken place from November to December 2018. In each Working Group, interesting insights have been gathered to eventually compile the 2018 edition of Spotlights & Policy Briefs in the field of Consumer & Citizen Involvement, System Architecture and Implementation Modelling, Storage and Cross Energy Carrier Synergies, Regulatory and Market Development, Interoperability and Standardisation.

- **Policy Briefs:** The ERA-Net SES Knowledge Community unites scientific experts in smart energy systems. On the basis of their profound expertise, these researchers develop an informed opinion of key aspects which, according to their perspective, should be considered by policy makers. With its working groups, ERA-Net SES provides a platform for initiating and developing the expert discussions regarding the messages of the research community to the policy makers.
- **Spotlights:** The newsletter-type documents providing a collection of findings of ERA-Net Smart Energy Systems projects and the Knowledge Community. Spotlights keep projects and experts updated on the ongoing activities and intermediate results of the initiative. Spotlights concentrate on specific topics with high relevance for the different Working Groups, which are deemed as generally interesting and worthwhile to be shared with project participants and practitioners. All Knowledge Community experts are invited to discuss and comment the spotlights. Based on the final versions of the spotlights the respective Living Documents are being kept up-to-date.

Annual ERA-Net SES Project Reporting for 2018 starts in January 2019

The annual project reporting period of the ERA-Net SES projects will start January 15, 2019 and last until February 28, 2019. Please prepare by **informing us who will be responsible** for the reporting from your project and ensuring all of them are registered on [expera](#).

The annual ERA-Net SES project reporting complements the reporting on national level. As previously, the ERA-Net SES Call Management and Support Team will evaluate your answers. While **Call Management** forwards reported **budget- and progress-related results** to the funding agencies, the Support

Team evaluation focuses on the **progress, activities, first results, knowledge community contributions and impact** of the projects. The results are used for updating the overview of the general results in Living Documents but are also the basis for in-depth **individual feedback** to projects.

Following your wishes and recommendations from former reporting periods, some improvements have been made to our **reporting tool on expera**. Nonetheless, you will be able to **build on previously entered information**. A manual for the project reporting will be distributed by January 15, 2019 at the latest to all ERA-Net SES projects. In order to allow for a smooth reporting process, **please inform us until January 14, 2019** which project member(s) will be **responsible(s) for your project's reporting** and make sure they are registered on [expera](#). In case the same members as last year will report, notification is not necessary.

ERA-Net SES events 2019

Please consider for your next year's planning that there will be a **Family of Projects Event** currently planned **for autumn 2019**. The event will allow the sharing of results and discussing current challenges among ERA-Net SES projects and include a communication workshop. During the event a feedback session based on your annual reporting will be held. It is also planned to welcome the new projects from our RegSys Joint Call 2018. As this year's event, the Family of Project Event will entail a Knowledge Community Meeting with Working Group sessions.

Please plan the participation of 2-3 members of your consortium. More information will be provided in due time.

General Information on ERA-Net Smart Energy Systems

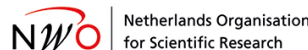
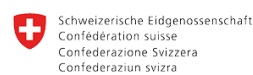

These co-operations pave the way towards implementation in real-life environments and market introduction.
